- No cost phone and e-visit appointments available.
- Effective April 1, 2020, Kaiser Permanente members who are diagnosed with COVID-19 will not have to pay co-pays or other cost-share related to their medical care and treatment of COVID-19, even if they have to stay in the hospital. This change applies to all admissions whose dates of service(s) are from April 1, 2020 through May 31, 2020. Co-pays or other cost-share includes, but is not limited to, hospitalization, office visits, telemedicine, emergency room visits, urgent care visits, and pharmacy.

- Essential Worker Child Care Vouchers Eligible applicants are being placed on a waiting list pending additional local or state funds. These vouchers will help pay for care through June 30. - COVID-19 Children's Fund This philanthropically-funded opportunity provides a 1-time payment of \$575 to the essential worker's child care provider. Parents can apply for the waitlist for funds. Application here.

#### **ICMA Retirement**

- Coronavirus-Related Distributions (CRDs) Eligible employees may withdrawal up to \$100,000 from their 457(b) plan due to economic and/or health related issues from COVID-19. The CRD is an available withdrawal option in 2020 from your 457(b) plan account balance only.
  - You are eligible for the CRD if you, your spouse, or dependent have been diagnosed with COVID-19. You may also qualify if you are experiencing adverse financial consequences as a result of being quarantined, having work hours reduced, or if you are unable to work due to lack of child care due to COVID-19.

• If your childcare provider costs have changed, you may change your contribution election with proper documentation. You must contact the Human Resources department within 30 days of the change.
